HOW TO GET A BOOTH AT THE MEADOWLARK MARKET

There are 4 categories of Vendors at the Meadowlark Market

- 1) PRODUCE - Certified Produce, Flower, and Plant Vendors
- 2) FOOD - Non-Certified Food Vendors
- 3) CRAFTS - Non-Certified Arts and Crafts Vendors
- 4) INFO - Informational Vendors

All Vendors selling in the Meadowlark Market are required to have the following listed documents. All documents must be current and a current copy of each document must be provided to the Market Manager before selling can begin in the Market. Current certificates, licenses, etc. that pertain to you as a vendor, must be displayed in your stall before you begin selling, and while you are selling.

ALL VENDORS:

A signed Meadowlark Market Vendor Agreement must be provided.

In addition to what is required from all Vendors, each category of Vendor has specific requirements:

1) PRODUCE

Certified Producer Certificate

Avocados - Certificate

Organic Producers - Independent Certification as an Organic Grower

Organic Producers - California Organic Registration

Plants and Flowers - Resale License

Plants and Flowers - Nursery Stock License

2) FOODS

Liability Insurance- Including Products liability for \$1,000,000 (one million dollars) per occurrence and naming the Meadowlark Community Church as additional insured.

Health Permit

Food Handlers Card

3) ART and CRAFTS

Liability Insurance - Including Products liability for \$1,000,000 (one million dollars) per occurrence and naming the Meadowlark Community Church as additional insured.

Resale License

4) INFO

Booth use is by pre-arrangement only, made with the Market Manager. There will be a limited number of these booths on a monthly basis.

VENDOR FEES

The current fees to participate in the market are :

Produce, Food and Art/Crafts Vendors:

One Space- (10 x 10) Minimum charge- **\$25** Up to \$250 in sales In addition, 8% fee for balance of sales over \$250 (Agriculture Fee: \$15.00 minimum and 8% of sales over \$150)

Two Spaces-(10 x 20) Minimum Charge- **\$40** Up to \$500 in sales. In addition, 10% fee for balance of sales over \$500 (Agriculture Stall two Spaces- \$20 for 10% over \$200)

Info/ Commercial/ Business Vendors: (Non Hand Made)

Booth rental is \$75 on a once a month basis. Call the Market Manager for scheduling.

Scheduling based on availability and a rotation of vendors.
